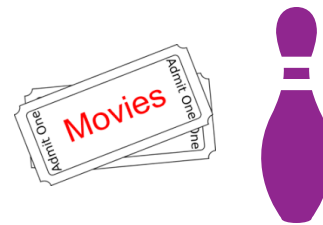
**NO SCHOOL DAY TRIP TO A MOVIE & BOWLING
