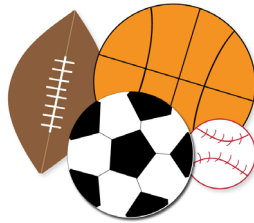
**COED MIGHTY MITE NIGHTS
